

Limited Slip Differential Lock Kit CT Series Turf Mower or Groundsmaster® 3400 Series Traction Unit

Model No. 02904—Serial No. 40000000 and Up

Installation Instructions

This kit provides a limited slip differential to improve traction when traction is reduced in certain ground conditions.

Important: Use of the limited slip differential lock kit is not recommended for machines that are operated for extended periods on the road. If you anticipate operating the machine on the road extensively, request that your dealer/distributor service provider limit the ground speed of the machine to 16 km/h (10 mph).

Preparing to Install the Limited Slip Differential Lock Kit

Preparing the Machine

- 1. Park the machine on a level surface.
- 2. Disengage and lower the cutting units.
- 3. Engage the parking brake.
- 4. Shut off the engine and remove the key from the key switch.
- 5. Wait for all moving parts to stop.
- 6. Allow the engine to cool completely.

Opening the Hood

- 1. Insert the hood key into the lock for the hood and rotate the lock 90° counterclockwise (Figure 1).
- 2. Press the button of the hood latch (Figure 1).




3. Carefully rotate the hood back and down (Figure 2).

Disconnecting the Battery


- When disconnecting or connecting the battery, do not allow the battery terminals to touch any metal parts of the machine.
- Do not allow metal tools to short between the battery terminals and metal parts of the machine.

1. Lift the cover of the negative battery cable (Figure 3).



Remove the negative battery cable from the battery (Figure 3).

Note: Position the negative battery cable where it cannot contact the negative battery post.

3. Lift the cover of the positive battery cable.

Note: Lifting the cover will loosen the battery cable terminal from the positive battery post.

4. Remove the positive battery cable from the battery.

Raising the Operator's Platform

Move the platform latch handle to the unlock position and tilt the operator's platform forward as shown in Figure 4.




Installing the Limited Slip Differential Valve

1. Clean the area around the traction manifold of debris (Figure 5).



- Front of the machine
- 2. Plug (traction manifold)
- Remove the plug from the port at left side of the traction manifold (Figure 6).



- 3. Limited slip differential
- Manifold port

Plug (traction manifold)

- 3. Insert the limited slip differential valve into the traction manifold and thread the valve in by hand (Figure 6).
- 4. Check that the O-ring on the limited slip differential valve has not moved out of place.
- 5. Torque the valve to 136 to 149 N·m (100 to 110 ft-lb).

Finishing Installing the Kit

Lowering the Operator's Platform

- 1. Lower the platform carefully; refer to Figure 4 in Raising the Operator's Platform (page 3).
- 2. Move the locking-latch handle toward the front of the mower as the platform nears the fully lowered position; refer to Figure 4 in Raising the Operator's Platform (page 3).

Note: This ensures that the latch hooks clear the locking bar.

3. Fully lower the platform and move the locking handle toward the rear of the mower (Figure 7) until the latch hooks fully engage the locking bar.



Checking the Hydraulic Fluid

Check the hydraulic fluid level in the tank—add hydraulic fluid as needed; refer to Checking the Hydraulic Fluid in the *Operator's Manual* for your machine.

Connecting the Battery Cables

A WARNING

Incorrect battery cable routing could damage the machine and cables, causing sparks. Sparks can cause the battery gases to explode, resulting in personal injury.

- Always disconnect the negative (black) battery cable before disconnecting the positive (red) cable.
- Always connect the positive (red) battery cable before connecting the negative (black) cable.
 - 1. Connect the positive battery cable to the battery post; refer to Disconnecting the Battery (page 2).
 - Align the insulator cover of the battery-cable terminal and close the cover; refer to Disconnecting the Battery (page 2).

Note: Closing the cover will tighten the battery cable terminal from the positive battery post.

- 3. Connect the negative battery cable to the battery post; refer to Figure 3 in Disconnecting the Battery (page 2).
- 4. Align the insulator cover of the battery-cable terminal and close the cover; refer to Figure 3 in Disconnecting the Battery (page 2).

Note: Closing the cover will tighten the battery cable terminal from the negative battery post.

Applying the Serial Label and Lowering the Hood

- 1. Apply the serial label to the left frame rail, adjacent to the machine serial label.
- 2. Close and secure the hood; refer to Opening the Hood (page 1).
- 3. Rotate the lock 90° clockwise to the LOCK position; refer to Opening the Hood (page 1).

Operation

Using the Limited Slip Differential Lock

The limited slip differential valve operates automatically, it prevents the front wheels rotating considerably faster than the rear wheels. Because of the 4 wheel drive on demand transmission system, slip in the front wheels will cause the drive to engage for the rear wheels.

A Limited Warranty

Conditions and Products Covered

The Toro® Company and its affiliate, Toro Warranty Company, pursuant to an agreement between them, jointly warrant your Toro Commercial product ("Product") to be free from defects in materials or workmanship for two years or 1500 operational hours*, whichever occurs first. This warranty is applicable to all products with the exception of Aerators (refer to separate warranty statements for these products). Where a warrantable condition exists, we will repair the Product at no cost to you including diagnostics, labor, parts, and transportation. This warranty begins on the date the Product is delivered to the original retail purchaser. * Product equipped with an hour meter.

Instructions for Obtaining Warranty Service

You are responsible for notifying the Commercial Products Distributor or Authorized Commercial Products Dealer from whom you purchased the Product as soon as you believe a warrantable condition exists. Owner Responsibilities

As the Product owner, you are responsible for required maintenance and adjustments stated in your Operator's Manual. Failure to perform required maintenance and adjustments can be grounds for disallowing a warranty claim

Items and Conditions Not Covered

Not all product failures or malfunctions that occur during the warranty period are defects in materials or workmanship. This warranty does not cover the following:

- Product failures which result from the use of non-Toro replacement parts, or from installation and use of add-on, or modified non-Toro branded accessories and products. A separate warranty may be provided by the manufacturer of these items.
- Product failures which result from failure to perform recommended maintenance and/or adjustments. Failure to properly maintain your Toro product per the Recommended Maintenance listed in the Operator's Manual can result in claims for warranty being denied.
- Product failures which result from operating the Product in an abusive, negligent or reckless manner.
- Parts subject to consumption through use unless found to be defective. - Normal noise, vibration, wear and tear, and deterioration.
- Normal "wear and tear" includes, but is not limited to, damage to seats due to wear or abrasion, worn painted surfaces, scratched decals or windows, etc.

Parts

Parts scheduled for replacement as required maintenance are warranted for the period of time up to the scheduled replacement time for that part. Parts replaced under this warranty are covered for the duration of the original product warranty and become the property of Toro. Toro will make the final decision whether to repair any existing part or assembly or replace it. Toro may use remanufactured parts for warranty repairs.

Note Regarding Deep Cycle Battery Warranty:

Deep cycle batteries have a specified total number of kilowatt-hours they can deliver during their lifetime. Operating, recharging, and maintenance techniques can extend or reduce total battery life. As the batteries in this product are consumed, the amount of useful work between charging intervals will slowly decrease until the battery is completely worn out. Replacement of worn out batteries, due to normal consumption, is the responsibility of the product owner. Battery replacement may be required during the normal product warranty period at owner's expense.

Maintenance is at Owner's Expense

Engine tune-up, lubrication cleaning and polishing, replacement of Items and Conditions Not Covered filters, coolant, and completing Recommended Maintenance are some of the normal services Toro products require that are at the owner's expense.

General Conditions

All implied warranties of merchantability and fitness for use are limited to the duration of this express warranty.
