



# Evaporative Emission Control Warranty Statement

California and Federal Evaporative Emission Control Warranty Statement  
Your Warranty Rights and Obligations



## Introduction

The California Air Resources Board (CARB), the Environmental Protection Agency (EPA), and Exmark Manufacturing Company are pleased to explain the evaporative emission control system's warranty on your 2018-2019 model year equipment. In California, and other states, new equipment that use small/large off-road spark ignition engines must be designed, built, and equipped to meet the State's stringent anti-smog standards. Exmark Manufacturing Company must warrant the evaporative emission control system on your equipment for the period listed below provided there has been no abuse, neglect, or improper maintenance of your equipment leading to the failure of the evaporative emission control system.

Your evaporative emission control system may include parts such as: carburetors, fuel tanks, fuel lines (for liquid fuel and fuel vapors), fuel caps, valves, canisters, filters, clamps, connectors, and other associated emission-related components.

## Manufacturer's Warranty Coverage:

This evaporative emission control system is warranted for two years. If any evaporative emission-related part on your equipment is defective, the part will be repaired or replaced by Exmark Manufacturing Company.

## Owner's Warranty Responsibilities:

As the equipment owner, you are responsible for performance of the required maintenance listed in your Operator's Manual. Exmark Manufacturing Company recommends that you retain all receipts covering maintenance on your equipment, but Exmark Manufacturing Company cannot deny warranty solely for the lack of receipts.

As the equipment owner, you should be aware that Exmark Manufacturing Company may deny you warranty coverage if your equipment or a part has failed due to abuse, neglect, improper maintenance, or unapproved modifications.

You are responsible for presenting your equipment to an Exmark Manufacturing Company service center as soon as the problem exists. The warranty repairs should be completed in a reasonable amount of time, not to exceed 30 days. If you have a question regarding your warranty coverage, you should contact Exmark Manufacturing Company at 1-800-667-5296.

## General Evaporative Emissions Warranty Coverage:

Exmark Manufacturing Company warrants to the ultimate purchaser and each subsequent purchaser that the equipment is:

- Designed, built, and certified to conform with all applicable emissions regulations; and
- Identical in all material respects to the parts as described in the application for certification; and
- Free from defects in materials and workmanship that could cause the failure of a warranted part

The warranty period begins on the date the equipment is delivered to an ultimate purchaser. The warranted period is two years. Subject to certain conditions and exclusions as stated below, the warranty on evaporative emissions-related parts is as follows

1. Any warranted part that is not scheduled for replacement as required maintenance in the written instructions supplied, is warranted for the warranty period stated above. If the part fails during the period of warranty coverage, the part will be repaired or replaced by Exmark Manufacturing Company. Any such part repaired or replaced under warranty will be warranted for the remainder of the warranty period.
2. Any warranted part that is scheduled only for regular inspection in the written instructions supplied is warranted for the warranty period stated above. Any such part repaired or replaced under the warranty will not reduce the period of warranty coverage and will be warranted for the remainder of the warranty period.
3. Any warranted part that is scheduled for replacement as required maintenance in the written instructions supplied is warranted for the period of time prior to the first scheduled replacement date for that part. If the part fails before the first scheduled replacement, the part must be repaired or replaced by Exmark Manufacturing Company. Any such part repaired or replaced under warranty will be warranted for the remainder of the period up to the first scheduled replacement point for the part.
4. Repair or replacement of any warranted part under the warranty provisions herein must be performed at an Authorized Service Dealer at no charge to the owner.
5. Warranty services or repairs will be provided at all Service Dealers authorized to service the subject equipment.
6. The equipment owner will not be charged for diagnostic labor that is directly associated with diagnosis of a defective, emission-related warranted part, provided that such diagnostic work is performed at an Authorized Service Dealer.
7. Exmark Manufacturing Company is liable for damages to other engine or equipment components proximately caused by a failure under warranty of any warranted part.
8. Throughout the evaporative emission control system's warranty period stated above, Exmark Manufacturing Company will maintain a supply of warranted parts sufficient to meet the expected demand for such parts.
9. Manufacturer approved replacement parts may be used in the performance of any warranty maintenance or repairs and must be provided without charge to the owner. Such use will not reduce the warranty obligations of Exmark Manufacturing Company.
10. Add-on or modified parts that are not approved by Exmark Manufacturing Company may not be used. The use of a non-approved, add-on, or modified part by the purchaser will be grounds for disallowing a warranty claim. Exmark Manufacturing Company will not be liable to warrant failures of warranted parts caused by the use of non-approved, add-on, or modified parts.

## Warranted Parts:

The repair or replacement of any warranted part otherwise eligible for warranty coverage may be excluded from such coverage if Exmark Manufacturing Company demonstrates that the equipment has been abused, neglected, or improperly maintained, and that such abuse, neglect, or improper maintenance was the direct cause of the need for repair or replacement of the part. That notwithstanding, any adjustment of a component that has a factory installed, and properly operating, adjustment limiting device is still eligible for warranty coverage. The following emission warranty parts list are covered:
