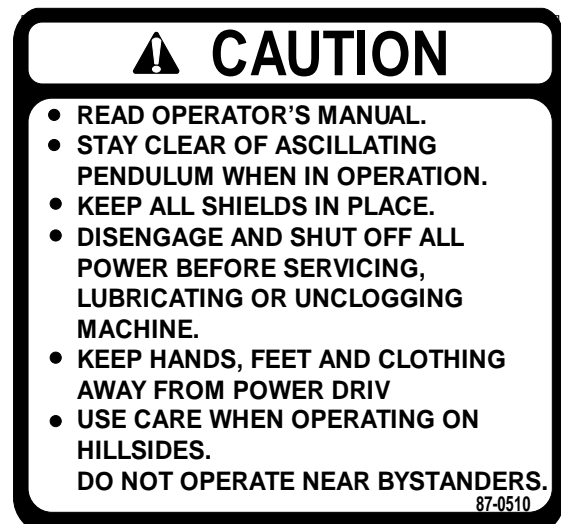
The following Decals are installed on the machine. If any become damaged or illegible, replace them. The decal part number is listed below.

Part No. 87-0470: Located on rear of Hopper.



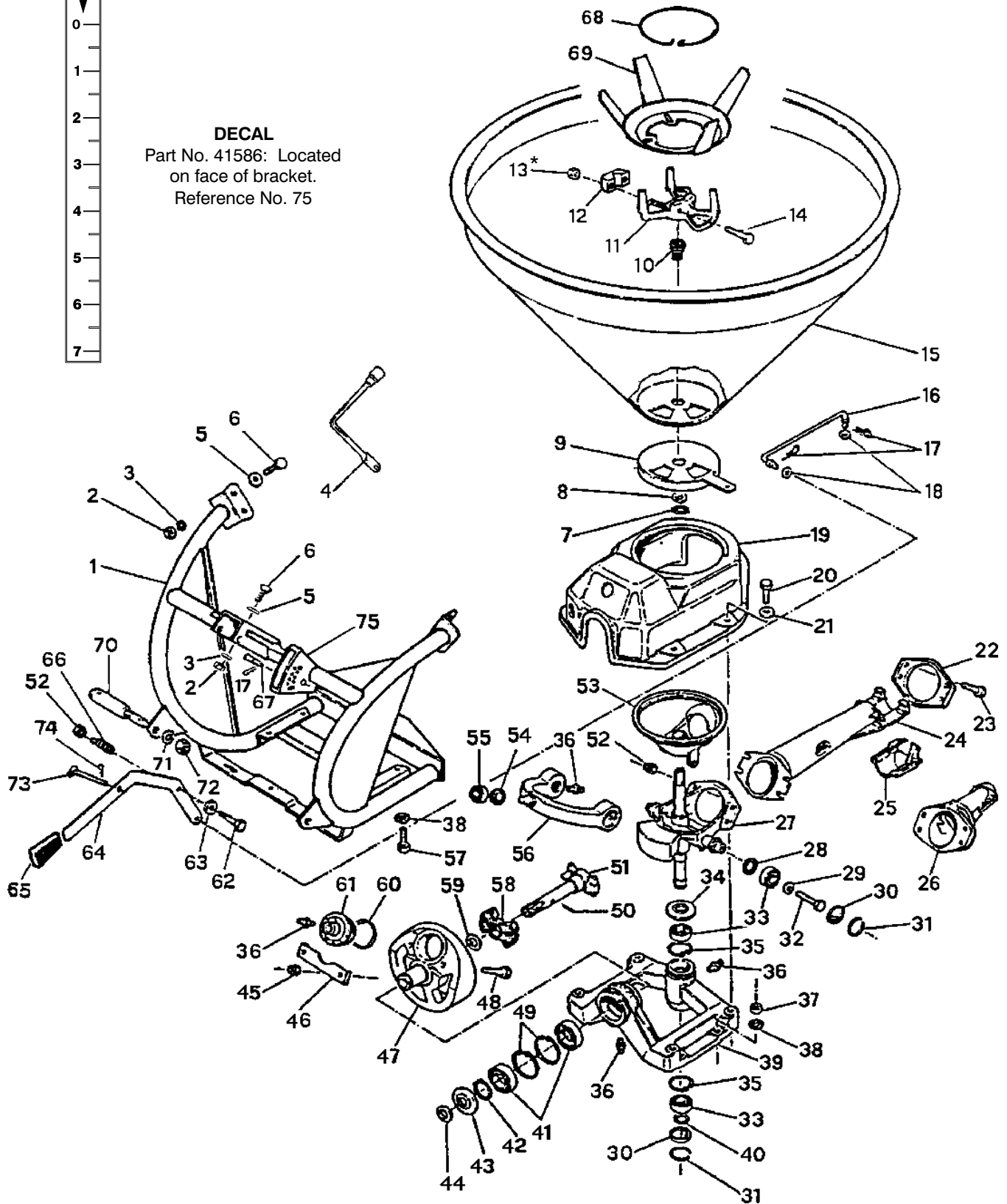
Part No. 62-5550: Located one on each side of Spreader Frame.

## IDENTIFICATION AND ORDERING

### MODEL AND SERIAL NUMBERS

All TORO products have identification numbers; a model number and sometimes a serial number. In any correspondence concerning the unit, supply the model number and, if available, serial numbers to ensure correct information and replacement parts are obtained.

To order replacement parts from an Authorized TORO Service Dealer, supply the following information:

1. Model and serial number of your vehicle.
2. Part number, description, and the quantity of part(s) desired.

**NOTE:** Do not order by reference number if a parts catalog is being used; Use the PART NUMBER.

## **The Toro Promise A One Year Limited Warranty**

*The Toro Company promises to repair your Model 41150 Spreader if defective in materials or workmanship. The following time periods from the date of purchase apply special warranty terms, on certain components, may be offered through The Toro Company by the component manufacturers:*

### **Commercial Products.....1 Year**

*The cost of parts, labor and transportation are included.*

If you feel your TORO Product is defective and wish to rely on The Toro Promise, the following procedure is recommended:

1. Contact your Authorized TORO Distributor or Commercial Dealer (the Yellow Pages of your telephone directory is a good reference source).
2. The TORO Distributor or Commercial Dealer will advise you on the arrangements that can be made to inspect and repair your product.
